- (b) To enter into technical and financial arrangements with national and International agencies and Institutions for exchange of scientist, study, tour, training in specialized area of Science and Technical assistant in the establishment scientific Institution and for other matter consistent with the aims and objects of the Trust.
- (c) To work for the improvement of standard of social welfare activities in the state and the Nation.
- (d) To make planning and development of Institutionalize Education in accordance with the directives given by the competent authorities of the Educational Department, Director of Technical Education and/or other Govt. Departments. Universities in Odisha/ other State in India from time to time.
- (e) To establish libraries, reading rooms, audio visual aid centers, references, Index Libraries and any Technical study facilities for the benefit of the local area.
- (f) To arrange study tours in and outside Odisha.
- (g) To take such action as may be necessary to carry on activities of the Trust and organizations with similar objectives.
- (h) To assists, subscribe, cooperate with or affiliate with any other Trust/Society/Institutions whether incorporated or similar to do and enter into agreement with such organization as aforesaid for the fulfillment its objectives.

their departments and function for providing medical, surgical and nursing care of treatment for door and outdoor patients and such other institution, as the Board of Trustees may deem necessary or convenient for any of its purpose, all of which are charitable and not activity of profit.

- (k) To bring out, encourage and develop the inventive and research facilities of the pupils and teachers and to afford opportunity for research work in all sciences and field of engineering.
- (l) To take such steps by personal or written appeals or by advertisement otherwise as may be deemed expedient for the purpose of publishing the functions and activities of the Trust of procuring contributions to the funds of the Trust in shape of donation/subscriptions or otherwise to make enact, alter amend, repeal, reenact, and enforce rules and regulations from time to time for the management and conduct of the work, business, department, offices and affairs of the Trust and in respect of qualifications, Classes, conduct, functions, duties, remuneration and privilege of its Officers, staff, personnel, students, visitors and others connected with the Trust of any of its works, Institutions, activities or functions.
- (m) To negotiate and enter into an agreement with any Government, University, Municipality of any other public or private authority which may seem conducive or beneficial, improved or rendered more efficient, work or activity of the Trust.
- (n) To purchase, take or lease on in exchange or otherwise acquire any movable or immovable, which may be deemed necessary, expedient and desirable for any of the objects of the Trust.
- (o) To borrow money of receive money of deposit upon such terms funds and assets of the Trust as the Board of Trustees shall deem necessary or expedient for the objects of the Trust.
- (p) To enter into and carry out arrangements for joint working or for amalgamation with any other association, society, Institution or trust, having objects within the objects of the Trust.
- (q) Generally to do all such other things as are deemed incidental or conducive to the attainment of all or any of the above objects.
- (r) The Trust will be for the benefit of the Institutions to be created by this Trust and the Institutions so created by the Trust shall be only beneficiaries.

2. TRUST FUND

a) The Managing Trustee will stand the possessed of the Trust fund upon Trust and also to receive any income or interest, dividends, thereof and voluntary contribution, donation and gift and in the first place to reimburse themselves (other trustees) or pay and discharge all the costs, charges and expenses incurred in or about incidental to the administration of execution of the Trust of power vested by these presents and also all outgoing, taxes, rates, Assessments, dues, duties, levies and other taxes payable in respect thereof and the cost of meeting of ordinary replied to any immovable property if for the time being subject to the trust of these presents and subject thereto upon to apply the residue of the said interest, dividend and other income and at their discretion to utilize the whole or part of the corpus of the trust fund or charitable services in India including (1) relief to the poor, (ii) promotion of education, culture, literature art and science and (iii) medical relief as per definition of "Charitable Purposes" in Section 2(15) of the Income Tax Act, 1961 as the Trustees may think fit and in such manner as the Trustees may think for one or more such public charitable purposes as aforesaid to the execution of one or more as the Managing Trustees may think fit so as not to violate the provisions of Income Tax Act, 1961. Provide that the said income as well as corpus of the Trust fund shall be utilized only towards charitable purposes as aforesaid in India and any accumulation of income shall also be made and deemed to be made for application for such charitable purposes as aforesaid in India accordance with the provisions of Income Tax Act, 1961.

b) Without prejudice to the generality of judging objects or purposes but subject to aforesaid, it is declared that the Managing Trustee shall each year utilize the income of the Trust and may at for discretion at any time and from time to time utilize the Trust fund in or forwards any one of the objects of the Trust as mentioned in Clause 1.

The surplus and unapplied portion of the said Income, if any, arising in any one or more year or years shall be accumulated and for invested in accordance with the provisions of Income Tax of 1961 as may be in force from time to time.

c) There shall be maintained all accounts of the Trust regularly. The accounts shall be audited by an auditor every year.

3. POWER AND FUNCTIONS OF THE MANAGING TRUSTEE

a) The management and affairs of the Trust shall vest in the Managing Trustee who will represent the trust or its institutions before all courts and authorities and exercise such power as his necessary for conduction the affairs of the Trust or its institutions, with powers to nominate and whose decisions in all matters shall be final.

b) To decide all questions arising in the administration of the Trust here of and including all questions relating to the interpretation of those presents, the admission of any institutions, maintained by the Trust or concerning anything or any matter relating to or connected with or arising out of these presents of the operation thereof. The decision of the Managing Trustee on all or any of the matters aforesaid shall be final.

c) To appoint and dismiss and reappoint Executives, Teaching staff, Officials, Engineers, Doctors, Nurses, Clerks, Caretakers, Attendants and other employees on such salary and on such she may think fit.

To delegate by power of Attorney or otherwise by way of resolution, to any Trustees or any other persons, powers and authorities implied by law or conferred by statute of vested in the Trustees. The Trustee(s) shall, however, not be held liable or responsible for the acts or defaults of any such persons but only for their own respective acts and defaults.

(d) To deposit by way of shape custody and documents held by her relating to any property belonging to the Trust with any bank and to pay sum payable in respect of such deposit.

(e) The Managing Trustee and Member Trustees are hereby authorized to invite or accept donation of money, shares, debentures, bonds and other movable or immovable properties from Author/Setler or anyone else by way of gift, grants, legacy or otherwise on such term and conditions as they may think fit not being inconsistent with the terms and conditions of their presents and such donations shall be held by Managing Trustee as accretion and augmentation of the Trust fund.

(f) Whether necessary the Managing Trustee may opt to retire or otherwise will have power to nominate his/her successor to be posted in the resolution of the board of Trustees and the successor so chosen will have all rights and liabilities of

the Managing Trustee as if duly appointed. Such nomination may be changed from time to time.

(g) The Managing Trustee shall be solely responsible to purchase, construct or hire or take on lease any immovable or movable property for all or any of the purposes of this Trust at such price cost or rent and on such terms and conditions and for such period and with or without portions for renewal as she deems fit. In case the immovable property owned by the settler or Managing Trustee or including the Member Trustee, is taken on lease, the rent payable shall not exceed the fair market rent, as assessed by the local authority or fixed by a well recognized or well known real estate dealer of the locality.

(h) Where the Managing Trustee in the purported exercise of the Trusts, discretion and power, hereby or by law conferred, act on the advice of any counsel solicitor or other Lawyer, Engineer, Surveyor, land or estate agent, actuary or broker, cashier or accountant or experts, they or other Trustee(s) shall not be responsible for any loss that may result from acting on such activities but the commission shall be deemed to be authorized and proper and the advice shall operate to protect the Managing Trustees in the same manner as if the act or commission had been authorized and proper.

The powers so vested will be exercised by the Managing Trustee whether it is necessary and such exercise of power will not invalidate any transaction.

(i) The Managing Trustee is hereby vested with the power to open and operate bank accounts in any Bank and borrow or raise any amount of money from the Nationalized banks or others as may be required by the Trust upon such terms as may be deemed fit by him.

(j) The Managing Trustee vested with the power to let out, lease, devise, mortgage, change or license any property belonging to the Trust for such rent or accommodation and on such terms and conditions and for such period as he may think fit.

(k) The Managing Trustee is vested with the power to reimburse himself or pay and discharge out of the funds or any property subject to the terms of these presents and income thereof, all expenses that may be incurred in or about the execution of the Trust and powers of these presents, including reasonable amount of travelling expenditure and its related expenses incurred for attending any activity of the Trust.

(l) Upon any sale or other transfer by the Managing Trustee, under the power aforesaid the purchaser, purchasers, transferees dealing bonafide shall not be

concerned to see or inquirer whether the occasion for execution or exercising such power has arisen or whether the provisions as to the appointment and retirement of trustees here in contained have been properly and regularly observed and performed except that the decision to sell the properties has been taken in accordance with these, presents. Neither shall the purchaser or purchasers, transferee or transferees be concerned to see the application of the purchase money or other consideration or be answerable for the loss, misappropriation thereof. The purchasers shall get a valid title in respect of properties purchased in good faith from the Managing Trustee.

(m) Subject to any mandatory provisions of any law for the time being in force and applicable to the Trust, the Managing Trustee shall invest all money which shall require investment in any investments or properties of whatsoever nature and whatsoever situate and whether involving liabilities or producing income or not or whatsoever situate and whether involving liabilities or producing income or not or upon personal credit with or without security and in the manner authorized by law and the Income Tax Act, 1961 for the investment of Trust funds and to call convert for exchange such investments and properties both movable and immovable whether he in his absolute discretion, thinks it desirable to do so.

(n) The Managing Trustee is vested with the power to decide all the matters pertaining to admission of students of any Institute managed by this Trust. His decision in this regard shall be final.

(o) To compromise, compound, abandon, submit to arbitration or otherwise settle any actions, suits, proceedings, debts, claims or things whatsoever arising out of the administration of the Trust fund or any instruction maintained and for any of these purpose may enter into, give, execute and sign agreement, instruments, arrangements, release and other things as may seem to them expedient without being liable or responsible for any loss occasioned by any act or things so done by them in good faith and fully as in he as absolutely entitled to the Trust fund and the said institutions without being answerable for any loss, occasioned in good faith.

(p) The Managing Trustee will have all powers of Board of Trustees when the Board of Trustee are not in the meeting. He will exercise the powers of Board of Trustee.

4. POWERS AND FUNCTIONS OF BOARD OF TRUSTEES

(b) To delegate by power of attorney or otherwise by way of resolutions, to any Trustees or any other person or persons, powers and authorities implied by law of conferred by statute or vested in the Trustees by these presents. The Trustee(s) shall however not be held liable or responsible for the acts or defaults of any such person or persons but only for their own respective acts and defaults.

c) To set up one or more Managing committees/Governing council from among themselves and other persons nominated by the Trustee(s) for the routine and day to day management and administration of any such institution under their ultimate supervision and control. The Member of such committees/council shall be nominated for a period not exceeding two years. The Trustee(s) shall be entitled to frame the contribution and regulate the procedure of such committee and to delegate to them such power as he/they may consider proper and necessary. The Trustee(s) will also decide about the quantum of sitting fee and travelling allowance to be paid to the nominated council/committee members.

d) To frame such rules and regulations for the management and make administration of regulations set up by the Trust as they think fit and to alter or vary the same from time to time and to make new rules and regulations provided that such rules and regulations shall inno case be inconsistent with terms of these presents.

e) To accept the new member(s) to the Trust or the resignation of the member(s) if he/they desire so.

f) To expel any member if his/her activity will be against the aim and objective of the Trust of the growth improvement of the Trust which has to be accepted by the majority of the Trustees?

g) To appoint any Advisory committee to help the Trustees in the Management of the affairs of the Trust or any institutions maintained or run by it and the discharge of their duties on such terms and conditions as they may determine.

h) To transfer all the Assets of the Trust, fund to any other Trust or institutions having similar to those of this Trust in the event of the Trustees unanimously coming to the conclusion that they are unable to continue to manage the affairs of the Trust.

i) To do all such other lawful things as may be incidental or conducive to the attainment of the objects of the Trust.

j) For the receipt of any money paid or any stock, funds or securities or the investments transferred to them in the execution of the Trust or powers hereof of for the purpose money paid to them, the Trustee shall effectually discharge the person or persons paying or transferring the same therefrom.

k) The Managing Trustees of other Member Trustees shall not be entitled to use or apply any Trust property or income thereof for his/their personal benefit in lieu of or for remuneration (and assistance) of the services rendered or to be rendered by him/her of them for the Trust except what remuneration has been provided for in this Trust.

l) The Managing Trustees within the powers conferred upon them.

(m) The Managing Trustees will be answerable before trust and will be work under Chairman of the Trust.

(n) Managing Trustee will be on rotation if required.

5. AMENDMENT OF THE CLAUSES

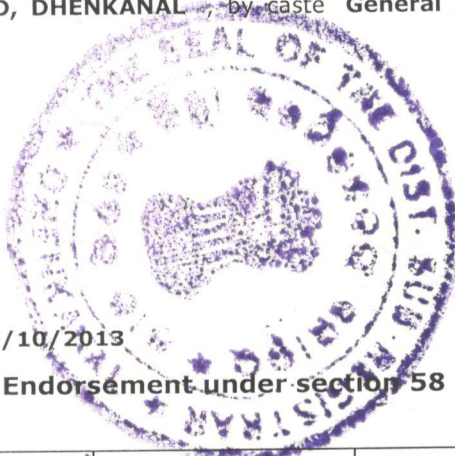


